**Request for Expression of Interest

1. State government province 5, Ministry of Industry, Tourism, Forest and Environment (MOITFE), Industry, Commerce and Consumers Welfare Directorate (ICCWD) has allocated budget for feasibility / detailed study of mines and minerals in province 5.
2. The Industry, Commerce and Consumers Welfare Directorate (ICCWD) Siddarthanagar, Rupandehi now invites Expression of Interest (EOI) from eligible consulting firms (Consultant) to provide the following consulting services : consulting service for preparation of report on "Feasibility study of mines and minerals (stone, slate, lime stone, metal and others) in province".
3. Interested eligible consultant may obtain further information at the office of the Industry, Commerce and Consumers Welfare Directorate, Siddarthanagar, Rupandehi during office hour.
4. The Qualification requirement of the consulting firms is:
 - Firm registration certificate.
 - Permanent Account Number (PAN).
 - Value Added Tax (VAT) registration certificates.
 - Tax Clearance Certificate of previous fiscal year from the Inland Revenue Office.
 - Minimum five Years of Experience in similar types of assignment.
 - Curriculum Vitae of the key personnel to be involved in the proposed assignment.
 - In case of joint venture firm, a joint venture agreement.
5. The applicant firm shall provide all the required information with supporting documents. In case of application from joint venture firm, clearly specify:
 - Descriptions, Organization and Employees of the firm of company.
 - If two or more firms of companies are to provide consultancy service as a group, organization or a joint venture, the name, address, profile of such firm or company and name of lead company or firm.
 - Description of the assignments of similar nature completed in the past five years and their location.
 - Curriculum Vitae of the key personnel to be involved in the proposed assignment.
6. Expressions of interest must be delivered online through e-GP system <https://bolpatra.gov.np/egp> to the address The Industry, Commerce and Consumers Welfare Directorate, Siddarthanagar, Rupandehi on or before 12 o'clock 6th February 2020. Submission of hardcopy will not be accepted.
7. Expressions of Interest shall be opened in presence of Bidder's representatives who choose to attend on 17.00 o'clock 6th February 2020 at the office of Industry, Commerce and Consumers Welfare Directorate, Siddarthanagar, Rupandehi.
8. In case the last date of obtaining and submission the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
9. EOI will be assessed based on Qualification of key personnel 40%, Experience of the consulting firm 40 % and capacity of consulting firm 20%. Based on the evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
10. Minimum score to pass is 60.
